Delivery:

All custom Triathlon and Cycling orders are accepted on a first-come-first-serve-basis. Please place your order early. Your delivery date will depend on when we receive your final order. Delivery is subject to the current production schedule and unless a specific date has been agreed upon in writing, delivery may be postponed. Completed orders will be shipped after customers balance is paid in full. Express shipments are possible but we will charge the additional air freight costs. All prices are FOB Florida/Bradenton. Orders within Florida will also have an additional charge of Florida Sales Tax if no Reseller certification is provided.

Orders Shipped Outside of the United States

Changes:

PRICING

All prices, terms, and our policies are subject to change without notice. However, if you are unsure about any of our products, please contact us via phone or email before ordering.

RECEIPT OF GOODS

All claims for the loss or damage of merchandise must be made by the customer directly against the carrier. Once the products have been picked up by the carrier company, Hawk Racing™ is not responsible for the damage or loss of products. We, therefore, will NOT accept payment deductions or give any credit in these instances.

SHIPPING & HANDLING

All products are shipped using United States Postal Service with no insurance or signature required.

SELLING PRODUCTS ONLINE

You are required to read, sign and agree to our Internet Policy. The Internet Policy Agreement (separate) MUST be sent to Hawk Racing along with your dealer application.

WARRANTY

Please contact us with your invoice number and part number, and specific defect for a return authorization. If item is within its warranty period, Hawk Racing will assign a RA number for the return. Write the RA number on the outside of the box and return the defective product with a brief description of the defect included inside the box. We will credit your account upon approval. Customers must register Hawk Racing products within 10 days of purchase to extend the warranty period. Bottom Bracket issues will only be replaced by the same color bottom brackets. WE DO NOT RECOMMEND OF OUR BOTTOM BRACKET WITH A MTB.

NEW ACCOUNTS

Hawk Racing requires the return of our internet policy incl. billing and shipping information on all customers before an order is shipped. All new account orders MUST be pre-paid with a Credit Card or CHECK until Open account terms have been approved.

Standard Open Account terms are NET 30 and are due in full, 30 days from invoice date. Past due accounts are subject to a finance charge of 2% per month on the past due balance. All accounts are subject to sales and credit management approval.

RETURNED CHECKS

Any refused order is subject to a 20% restocking fee and all applicable shipping costs. All custom orders, which are Pre-paid only, are completely non-refundable.

BOTTOM BRACKET PROGRAM

All Bottom Bracket Program orders MUST be pre-paid before shipping in order to purchase the bottom bracket at the reduced rate. Only Level 1 and Level 2 dealers have NET 14 or NET 30 day accounts with reduced rate. Please contact us to update your account to establish a higher gross profit margin on our products.
